Participation fee

The participation fee for the entire period of the symposium (arrival 21 June, departure 26 June) amounts to

650.- Swiss francs (560.- US dollars) in a double room
800.- Swiss francs (690.- US dollars) in a single room

This fee comprises: board and lodging, coffee breaks (including soft drinks), transportation between the airport and the meeting place, documentation and simultaneous interpretation, social programme and closing banquet.
